CHAOS is a sophisticated 30m (98ft) Sunseeker superyacht built in 2010 and refitted in 2024. In survey with AMSA, CHAOS is licensed to sleep 8 guests and cruise with 36, offering elegance, class, and fantastic spaces for families or larger groups. Her interiors use warm, muted tones to create a homely feel, with large windows in the main salon that flood the space with natural light and offer panoramic views. The salon provides a comfortable space for lounging, complete with a large TV screen, while the dining table can seat up to 8 people for an intimate dining experience. CHAOS can accommodate up to 8 guests in 5 luxury staterooms, including a fullbeam master suite on the main deck with a large ensuite and wardrobe. On the lower deck, there are two VIP queen cabins and two twin cabins with Pullman berths suitable for children. The sundeck features a retractable sunroof, making it an all-weather area, with a dining area that comfortably seats 12 people, a full-service bar, built-in plasma screen TV, and entertainment space. Over the past three years, CHAOS has built a fantastic charter reputation on Sydney Harbour, becoming a very popular luxury charter vessel. Under exceptional management and with a full-time crew, she is maintained to the highest standards.

Special Conditions

Pick Up and Drop Off

Pick up and drop off are available from Eastern Pontoon, Rose Bay Ferry Wharf, Double Bay Ferry Wharf, King Street Wharf, Casino Wharf, and Eastern Pontoon.

Note: All guests are to be informed that the vessel has a 15-minute limit alongside designated wharves. Some ferry wharves may only be accessed upon request and are subject to Roads and Maritime NSW restrictions. Pick up and drop off times are dependent on ferry movements.

Alcohol

RSA laws will be strictly adhered to. Management reserves the right to cease service to any quests accordingly. No shots are permitted. Red wine is not allowed on the saloon carpet or lounge area.

Vessel Access Day Charter

There is no access to the lower deck or cabins unless arranged prior to the charter. Inspection of cabins can be requested during the charter.

Food

All dietary requirements and allergies must be disclosed prior to the charter date.

Music

Music volume will be controlled by the vessel's crew. DJs are allowed but must bring all their own equipment, including a table.

Smoking

Smoking is only permitted when the vessel is at anchor and on the swim platform with a crew member in attendance.

Shoes

A strict no-shoe policy applies in carpeted areas. Seating will be provided for guests to remove their shoes, which will be safely stowed onboard. Medical exemptions may be discussed with the captain prior to the charter.

Swimming

Swimming must be arranged prior to the charter and an additional deckhand may be required. Water toys are available on request.

Water Taxis

Guest transfers via water taxis or tenders must be approved by the captain. Costs are the responsibility of the guest.

Any extensions made on the day or additional consumption charges must be settled via credit card upon disembarkation. No commissions will be provided for any extensions made during the charter, including on-consumption beverages. The vessel enforces a zero-tolerance policy on illegal drugs, and strictly no strippers or topless entertainment are permitted. Same-day bookings are accepted, with BYO food allowed only if booked within 24 hours. The home berth is Jones Bay Wharf, where embarkation and disembarkation are not permitted; however, bump-in and inspections are available. A minimum twohour turnaround time is required between charters.
