*BYO Terms and Conditions Agreement*

---

All clients looking to book a BYO package on board Karisma 2 are required to read and sign off on the below BYO terms and conditions. This is to ensure awareness of the conditions prior to the event to eliminate any potential disputes or confusion on the day. This agreement is to be signed by the charterer and returned to the operator upon booking.

**BYO Food and Beverage Surcharges Include:**

- Assisted use of amenities such as fridges, oven to keep foods warm, glassware, ice, plates and cutlery, cleaning
- Cleaning up during charter
- Rubbish removal post-charter

\*If any additional guests attend on the day above the final numbers given for the event, the food and beverage surcharge will be charged to the organiser upon boarding

**\$250 Pre-handling and Stocking Fee Includes:**

- Crew member to take delivery at the vessel's berth prior to the day of the charter
- Bar set up/stocked ready for service on boarding (bottom bar only for BYO)

*\*This fee is not payable if beverages are brought within the 1-hour pre-access time before boarding*

**\$250 Return Collection Fee** - Guests are required to remove all leftover catering supplies and decorations at the end of the charter where possible – alternatively, a \$250 collection fee is applicable if the charterer requests for leftovers to be stored and collected on another day following the charter. This must be notified and paid for at the end of the charter before disembarkation, so that the crew knows whether to store the leftovers or discard them

**BYO FOOD**

**Pre-cooked /Prepared Foods Only**

Only pre-prepared or pre-cooked foods are permitted on board for BYO catering. The commercial oven is not available for use to keep items warm. A range of substantial items are required for BYO catering in order to meet our liquor licence conditions of providing 350 grams per person. If the amount of food brought on board on the day doesn't meet with these requirements, the Cruise Director will inform the organiser and they will be required to order additional pizzas delivered to the boat at a nearby wharf.

**IMPORTANT - External on-board chefs/catering companies are only considered upon application and under certain circumstances.**

**We have our own experienced chef/caterer with extensive menu options which you are welcome to look at booking should you wish to have professional catering on board. Please enquire for more information around this.**

**BYO BEVERAGES**

Drinks are not permitted to be brought on board at the boarding wharf. Due to the facilities, layout and service on board Karisma 2, all beverages must be delivered prior to charter (1 hour prior to boarding) to be set up at the bar and in our fridges ready for service on boarding. We strongly advise you deliver your drinks refrigerated/chilled where possible, or at least a portion of them to be served within the first hour of the charter, as the fridges will not have time to chill them to a cold temperature prior to first drink service.

A maximum variety allowance applies to BYO beverages due to fridge/storage space:

**(eg.) 2 types of beer/cider or premixed varieties, 2 chilled wines, 1 red wine, 4 spirits, 4 bottled mixers, bottled waters**

**BYO EXTERNAL SUPPLIER/VENDOR**

**\$100 fee per supplier**

This fee includes pre-access for your suppliers/vendors at our berth 1 hour prior to your pickup time, to bump in and set up.

Note for BYO DJs/Bands/Musicians - By law, music must be turned down to a low level when entering Darling Harbour or any public wharf. This applies when we are boarding or disembarking guests. If the entertainer is disembarking at the drop off location with guests, they need to shut down and begin packing up their equipment 10 minutes early due to limited time allocation on the wharf for drop off, otherwise they are welcome to travel back to our berth to bump out following the charter. Please see **Entertainers Doc** for more details.

**BYO T&Cs on Karisma 2**

- Substantial catering is to be brought on board to adhere to liquor licensing laws whilst alcohol is being consumed (minimum 350gm of food per person)
- Beverages will be served and monitored by RSA certified staff members on board
- No doubles/no shots will be served (Liquor License Condition)
- No pre-mixed drinks containing over 5% alcohol (Liquor License Condition)
- BYO leftover items are not legally permitted to be removed by intoxicated guests upon disembarkation at public wharves. If they organised to be held and collected during the days following the charter, a \$250 fee is payable upon disembarking the vessel. Any leftover BYO items will be held for a maximum of 3 business days post-charter (unless organised otherwise) and will then be discarded.
- No guests under 18 who are not accompanied by their parent or legal guardian will be refused at boarding. Guests without ID as proof of age will also be refused to board
- Staff have the right to refuse boarding of any intoxicated person
- The Captain has the right to remove any intoxicated person from the vessel at any time they deem necessary

**\*A maximum of 5 people are permitted to board at pre-access**

When unloading, you may pull into the marina entrance and briefly park in front of the bollards (as illustrated by the car in the photo below). Please be aware that this area can get busy during peak times, so we recommend allowing extra time for unloading and parking and keeping your stop as short as possible.

You can walk or wheel your items down the driveway and turn right at the bottom. You'll then see the marina entry gate and the ramp leading onto the marina. **Karisma 2** is berthed in the first position on the left as you enter the gate.

Metered street parking is available directly outside the marina on Bank Street, with a 6-hour limit. The rate is approximately \$6.40 per hour, and parking is free after 7:00 pm.
